ii) Introduction

This guidance document is designed to assist community nurses, occupational therapists, physiotherapists and other appropriate health and social care professionals to identify the most appropriate Community Care Equipment (CCE) to meet the needs of service users in Hull. If the guidelines do not fit individual circumstances, contact your service head/ lead professional and/or the Clinical Commissioning Lead at NHS Hull CCG.

This guidance should be read in conjunction with the document 'accessing the Community Care Equipment Service: A policy for prescribers'. The criterion has been developed with reference to the Care Act (2014). The eligibility threshold for adults with care and support needs is set out in the Care and Support (Eligibility Criteria) Regulations 2014 (the "Eligibility regulations"). The threshold is based on identifying how a person's needs affect their ability to achieve relevant outcomes, and how it impacts on their wellbeing.

Example Specification Sheet

Type of equipment

General description of the equipment and the section of the category. Specific make may change with time and close technical equivalent (CTE) may be provided.

Criteria for provision

General guidelines listed in this document must be met in all cases, however there will be specific criteria for each item of equipment under which provision may be authorised.

Practice guidelines

Considerations for prescription, supply, fitting and use of the equipment.

Carers' considerations

Additional considerations relating to carers.

Contraindications and safety considerations

Key safety considerations.

Weight limit

Ordering, delivery and fitting implications

Information required by the provider to enable appropriate delivery/ fitting.

Maintenance

Highlights the actions required by the service user or carer to ensure the safe use of the equipment over time.

Prescribers Authorised to issue

Job codes to self-authorise and whether item is P store. If your job code is not listed you may be able to order the item and select an authoriser. Not all job codes will be able to order all items of equipment.

Delivery Options:

Routine or Emergency.

Repair Response:

All items will attract either an emergency (same day/ out of hours) or routine (3 day) repair/ replacement

Household: Perching stool

Type of equipment

Kitchen: L35579 Height adjustable perching stool with armrests and back rest. Only stools with back and arms are provided. Commercially available stools are generally not height adjustable nor have a sloped seat. If the Person does not require back and arms consider self-purchase of a commercially available stool, should this be sufficient. Perching stools are appropriate for use in the kitchen.

Criteria for provision

- Person has reduced standing tolerance and is unable to maintain standing in a safe manner for the duration of the task. AND
- Full seated position is not appropriate for the task i.e. meal preparation at a kitchen table.

Practice guidelines

- There needs to be sufficient room for the stool
- The person will require good sitting balance
- The stool has splayed legs which may present a trip hazard
- Where the Person does not require the support of a perching stool and a commercially available "standard stool" would suffice, the Person would be expected to self-purchase a stool.

Carers' considerations

Is the carer able to move the stool to gain access to the kitchen themselves?

Contraindications and safety considerations

Person must have good balance to tolerate the sloped seat.

Person must be able to put equal force through each armrest to prevent tipping.

Weight limit: 160KG

Unless a height is specified the driver as a trusted assessor will set the height.

Household: Bariatric perching stool

Type of equipment

Kitchen: N26464 Heavy duty, height adjustable perching stool with armrests and small back rest. Only stools with back and arms are provided. Perching stools are appropriate for use in the kitchen.

Criteria for provision

- Person has reduced standing tolerance and is unable to maintain standing in a safe manner for the duration of the task. AND
- Full seated position is not appropriate for the task i.e. meal preparation at a kitchen table. AND
- Person exceeds the weight limit for standard perching stool or commercially available stools.

Practice guidelines

- There needs to be sufficient room for the stool
- The person will require good sitting balance
- The stool has splayed legs which may present a trip hazard
- These stools are large and heavy and may be difficult for a Person to move.

Carers' considerations

This chair is heavier than standard and carer may need to move this for access to the kitchen.

Contraindications and safety considerations

Person must have good sitting balance to tolerate sloped seat.

Person must be able to put equal force through each armrest to prevent tipping. Weight limit: 280KG

Unless a height is specified the driver as a trusted assessor will set the height.

Household: Trolley

Type of equipment

Kitchen Trolley: M52183 A height adjustable, two shelved kitchen trolley.

If the Person has a walking frame, a caddy should be provided unless there is an exceptional circumstance.

Criteria for provision

- Person lives alone. OR
- Person is the carer for other people who reside in the property. AND
- Person does not have a safe and accessible space to eat in the kitchen. AND
- Person is unsafe to carry food or drinks from room to room.

Practice guidelines

- If the Person has a Zimmer frame, consider provision of a caddy.
- Check the Person will not put too much weight through the trolley as it may run away from them.
- It may be more appropriate for Person to eat at the kitchen work top with a perching stool.
- The floor coverings and thresholds must not cause a risk.
- Consider a referral to community physiotherapy

Carers' considerations

None.

Contraindications and safety considerations

This is not a mobility aid and should only be used for transporting food and drinks between rooms.

Weight limit: 177KG

Household: Caddy for walking frames

Type of equipment

Mobility: L29877 The caddy slots onto a Zimmer frame with no fixings. The centre of gravity remains over the front wheels to maintain stability. In most cases this will replace the need for a kitchen trolley for those who use a Zimmer frame. The caddy has one large and one small compartment, supplied with a tray that is designed to hold a plate of food.

Criteria for provision

- Person has been provided with a Zimmer Frame. AND
- Person meets the criteria for a kitchen trolley.

Practice guidelines

- Consider the risks of carrying food over thresholds or changes in floor coverings.

Carers' considerations

Contraindications and safety considerations

Maximum carry weight 2KG

This will be fitted to the frame as per instructed by the service user unless otherwise specified.

Bathing: Bath step

Type of equipment

Bathing: M99515 The 4" bath step can be placed outside the bath or shower to reduce the difference from the floor height.

Criteria for provision

- Person is unable to independently and safely stride in/out of the bath or shower.

Practice guidelines

- Non-slip rubber feet to reduce the risk of movement
- May be used in conjunction with bathboard, bath step or bathlift

Carers' considerations

- The bath step may present a falls hazard and therefore consideration is required as to whether a carer will be available to remove the step after use.

Contraindications and safety considerations

Person must have good balance

Weight limit of 127KG

Ordering, delivery and fitting implications

Bath step available for self-collection as a single item or delivery with other equipment.

Maintenance

Clean regularly with household detergent to prevent build-up of soap residue which could present a slip hazard.

Bathing: Adjustable width bathboard

Type of equipment

Bathing: N49839 Kingfisher bathboard with handle. Designed to satisfy the requirements of all bathboard users. It is width adjustable from 26.25" to 28.25". 260mm seat depth and the securing brackets can be adjusted independently to allow for fitment to a wide range of baths. The board can even be fitted into the curve at the back of the bath.

Criteria for provision

- Person is unable to independently and safely stride in/out of the bath.

Practice guidelines

- It can be used in conjunction with an over bath shower.
- If there is no shower the Person will require a jug or tap end mixer shower.
- If the Person is to transfer into the bath, consider using in conjunction with a bath seat and / or grab rails.

Carers' considerations

- Person will be at a good height for assisted bathing.
- Consider whether carer will be able to remove and re-fit safely.

Contraindications and safety considerations

Person must have sitting balance as no lateral or back support is provided Weight limit of 200KG

Ordering, delivery and fitting implications

Technicians will fit at the non-tap end of the bath unless otherwise instructed.

The Bathboard requires at least 25 mm lip between the wall and the edge of the bath.

Maintenance

Clean regularly with household detergent to prevent build-up of soap residue which could present a slip hazard.

Bathing: Bath seat

Type of equipment

Bathing: A plastic stool style bath seat available in either 6"/ 15cm (M78419), 8"/ 20cm (M78421) or 12"/ 30cm (M78433) heights, secured by rubber suckered feet.

Criteria for provision

- The Person is unable to rise from the bottom of the bath in a safe and effective manner.

Practice guidelines

- If the person is only using a bath seat, they will need to be able to step over the side of the bath and lower onto/ rise from the seat.
- Consider whether grab rails should also be recommended.

Carers' considerations

Carer needs to be able to release the suckered feet to remove the bath seat and be able to refit safely.

Contraindications and safety considerations

Weight limit: 160 Kg

General cleaning and visual checks before each use.

Bathing: Adjustable width swivel bather

Type of equipment

Bathing: M78597 Drive Medical Swivel Bather. A seat that can rotate and lock into position and facilitate movement over the bath side. The seat is fixed to a metal frame that rests securely on the rim of the bath. Back/ arm rests provide extra support. The base unit adjusts for bath widths between 660 mm and 710 mm. Rotates 360 degree via lever at the right hand side.

Criteria for provision

- Person is unable to use a bath board due to poor sitting balance and the requirement for back support. AND
- Where there is no over bath shower needs may be met through provision of a perching stool and strip wash. A referral to Social Services Occupational Therapy may be indicated for long term solution to access to bathing.

Practice guidelines

- The Person is able to sit on the swivel bather and lift their legs over the side of the bath with or without assistance.
- The bath rim needs to be 30 mm wide to accommodate the bather.
- Prescriber to ensure the Person or carer can operate the locking mechanism.
- Check whether grab rails are required.

Carers' considerations

Ensure the overhang of the frame does not cause an obstruction for anyone using the bathroom.

Carer needs to be able to remove and re-fit the bather if other people are to use the bath.

Contraindications and safety considerations

Weight limit: 160Kg

Ordering, delivery and fitting implications

Technician to fit at the non-tap end of the bath unless otherwise stated at the time of placing the order.

Maintenance

Person and carers advised to check the seat and brake before use.

Bathing: Reclining powered bath lift

Type of equipment

Bathing: M34132 Invacare Orca. A portable, compact two piece electric reclining bath lift. Quick release hand control, battery with Sony technology, back rest recline up to 40°. Comprehensive range of accessories available.

Criteria for provision

The individual's needs must be assessed and resolved in the simplest manner starting with teaching alternative techniques, using alternative shower facilities or more basic Community Equipment.

- The Person is unable to transfer into a bath in a safe and effective manner using bath board and / or bath seat. AND
- Person does not have a shower (over bath shower, shower in addition to bath or communal facilities, which they are able to access). AND
- Provision of a bath lift would enable the Person to achieve independent bathing.
- The Person requires assistance from a carer AND assisted use of the bath lift does not present a significant manual handling risk.

Practice guidelines

- The base of the bath will need to be wide enough to accommodate the bath lift
- The surface of the bath base will need to be non-textured to allow the suckers to stick securely
- Guard rails require where bath handles would prevent the safe operation of the
- Range of accessories available as specials.

Carers' considerations

Where the bath lift is not to remain in the bath all the time, check the ability of the carer/ Person to remove and re-fit the bath lift.

Ensure the carer/ Person is able to remove the battery/ handset from the bath lift to re-charge

Contraindications and safety considerations

Not to be used with certain bath oils as this may prevent the bath seat suckers from adhering to the bottom of the bath.

Weight limit: 140Kg

Ordering, delivery and fitting implications

Wide range of accessories available as specials.

Maintenance

Bath lift battery to remain on charge when not in use.

Annual service required from equipment provider.

Bathing: Fixed back powered bath lift

Type of equipment

Bathing: M68476 Invacare Orca F. A portable, compact two piece electric bath lift. The fixed back rest with integrated head support ensures a safe and comfortable

Criteria for provision

The individual's needs must be assessed and resolved in the simplest manner starting with teaching alternative techniques, using alternative shower facilities or more basic Community Equipment.

- The Person is unable to transfer into a bath in a safe and effective manner using bath board and / or bath seat. AND
- Person does not have a shower (over bath shower, shower in addition to bath or communal facilities, which they can access). AND
- Provision of a bath lift would enable the Person to achieve independent bathing.
- The Person requires assistance from a carer AND assisted use of the bath lift does not present a significant manual handling risk.

Practice guidelines

- The base of the bath will need to be wide enough to accommodate the bath lift
- The surface of the bath base will need to be non-textured to allow the suckers to stick securely
- Guard rails require where bath handles would prevent the safe operation of the bath lift
- Range of accessories available as specials.

Carers' considerations

Where the bath lift is not to remain in the bath all the time, check the ability of the carer/ Person to remove and re-fit the bath lift.

Ensure the carer/ Person is able to remove the battery from the bath lift to re-charge

Contraindications and safety considerations

Not to be used with certain bath oils as this may prevent the bath seat suckers from adhering to the bottom of the bath.

Weight limit: 140Kg

Ordering, delivery and fitting implications

Wide range of accessories available as specials.

Maintenance

Bath lift battery to remain on charge when not in use.

Annual service required from equipment provider.

Bathing: Adjustable height corner shower stool

Type of equipment

Bathing: N05370 A free standing, adjustable height corner shower stool. Seat height 450mm-600 mm, seat width 405mm and seat depth 390 mm.

Criteria for provision

- Person has reduced standing tolerance and is unable to maintain standing in a safe manner for the duration of the task. AND
- Person has a shower cubicle with insufficient space to accommodate a standard four legged shower stool.

Practice guidelines

- Ensure there is sufficient remaining space for mobility and transfers.
- Risk assessment required regarding the tri pod design and the risk of tipping the shower stool. The Person must have good sitting balance.

Carers' considerations

Is the carer able to move the shower stool if the shower is to be used by others? Is there sufficient room for carer access if required?

Contraindications and safety considerations

Person must have good sitting balance

Weight limit 127 Kg

Unless a height is specified the driver as a trusted assessor will set the height.

Bathing: Adjustable height shower stool

Type of equipment

Bathing: F20524 A free standing, adjustable height shower stool with raised handles. Seat height 480 mm-630 mm, seat width 380mm and seat depth 280 mm.

Criteria for provision

- Person has reduced standing tolerance and is unable to maintain standing in a safe manner for the duration of the task. AND
- Person requires the additional support of raised handles to assist in standing.

Practice guidelines

- Check that the splayed legs will not cause a trip hazard.
- If the shower stool is to be used in a shower cubicle, ensure there is sufficient remaining space for mobility and transfers

Carers' considerations

Is the carer able to move the shower stool if the shower is to be used by others?

Contraindications and safety considerations

Weight limit 127 Kg

Bathing: Adjustable height shower chair

Type of equipment

Bathing: M48295 An adjustable height, free standing shower chair with arms and back. Seat height 410 mm- 537 mm. Seat width 485 mm.

Criteria for provision

- Person has reduced standing tolerance and is unable to maintain standing in a safe manner for the duration of the task. AND
- Person is unable to use a shower stool due to lack of back support or the requirement for armrests.

Practice guidelines

- Check that the splayed legs will not cause a trip hazard.
- If the shower chair is to be used in a shower cubicle, ensure there is sufficient remaining space for mobility and transfers

Carers' considerations

Is the carer able to move the shower chair if the shower is to be used by others.

Contraindications and safety considerations

Weight limit 165kg

Unless a height is specified the driver as a trusted assessor will set the height.

Bathing: Adjustable height mobile shower chair

Type of equipment

Bathing: **M00754** A mobile shower chair with four braked castors. Height adjustment 483mm to 610mm, width 460mm and depth 420mm.

Criteria for provision

- Person is unable to stand long enough to use a shower safely. AND
- Person has a wet floor / level access shower (not for use in shower cubicles). AND
- Person is unable to mobilise safely into the shower area. OR
- It is inappropriate for Person to transfer from a wheelchair onto static shower chair (The Person needs to undress in another room or Person unsafe to transfer due to floor covering etc.).

Practice guidelines

- Four braked castors need to be deployed before transfers; therefore People are not advised to stand from the chair in the shower as one braked castor is usually inaccessible.

Carers' considerations

Is carer able to push the Person in the chair?

Are there changes in floor covering e.g. door threshold into the bathroom or lip on a level access shower tray?

Contraindications and safety considerations

Four braked castors need to be deployed before transfers are attempted.

Weight limit 165kg

Ordering, delivery and fitting implications

Unless a height is specified the driver as a trusted assessor will set the height.

Maintenance

Report any problems with the braked castors to the provider and do not use until repaired. General cleaning and visual checks before each use.

Bathing: Dual purpose adjustable height mobile commode

Type of equipment

Bathing: M83647 Dual purpose shower and commode chair which should also fit over a "standard" height toilet. Seat height 480 mm- 530 mm, Width 460 mm, depth 430 mm.

Criteria for provision

- The criteria for mobile shower chair and mobile commode is met and provision of one item of Community Equipment will best meet Person's needs.

Practice guidelines

- Ensure foot plates are used to reduce risk of Person catching feet.
- To be used over a toilet there needs to be clearance behind the toilet i.e. no boxed in waste pipes and enough room to either side of the toilet.
- Commode pan is accessed from the rear. Some people are unable to tolerate these being removed while they remain seated on the commode.

Carers' considerations

Is carer able to push the Person in the chair?

Are there changes in floor covering e.g. door threshold into the bathroom or lip on a level access shower tray?

Contraindications and safety considerations

Four braked castors need to be deployed before attempting transfers.

Weight limit 160kg

Ordering, delivery and fitting implications

Dual purpose chair will be delivered with footplates as standard.

Maintenance

Report any problems with the braked castors to the provider and do not use until repaired. General cleaning and visual checks before each use.

Bathing: Deluxe shower / commode chair (18", 19" or 21")

Type of equipment

Bathing: Shower and toileting chair for service users with specialist needs where other equipment has been considered/ trialled and deemed to be inappropriate. These chairs come in a modular format with the frame and accessories as stock items. There will be situations where joint visit with the equipment supplier representative may be appropriate with special order accessories required.

Criteria for provision

- Person meets the criteria for a mobile shower chair. AND
- Other stock items are inappropriate for Person and there is an essential clinical need for this equipment E.G. Postural support. OR
- Person requires a self-propelled shower/ commode chair.

Practice guidelines

- Prescriber should have attended training from NRS in how to assess and order these items.
- The prescriber is required to specify what options are required i.e. seat height, width, wheels etc. see guidance for further details.
- 19" frame should be used where a wash dry toilet is in situ.

Carers' considerations

Is carer able to push the Person in the chair?

Are there changes in floor covering e.g. door threshold into the bathroom or lip on a level access shower tray?

Contraindications and safety considerations

Weight limit: 200KG

Ordering, delivery and fitting implications

Not all the accessories available are stock items and it may be necessary to make a non-stock item request for this following joint visit with supplier's representative.

Maintenance

Report any problems with the braked castors to the provider and do not use until repaired. General cleaning and visual checks before each use.

- There are 3 frame options 18", 19" or 21".
- Each frame can be specified with either attendant push or self-propelled wheels. The self-propelled version comes complete with 22" wheels to the rear, unbraked front castor wheels and anti-tip bars. The attendant push version comes with 4 braked castors.
- The 18"/ 19" frames come with the medium horseshoe seat as standard. There is the option to specify the medium horseshoe with skirt for wash dry toilet.
- The 21" frames come with the large horseshoe seat as standard. There is the option to specify the large horseshoe with skirt for wash dry toilet.
- There are options of 1", 2" or 3" side pads as special orders which have the effect of reducing the seat width. Therefore these chairs offer a range of seating; 12", 14", 16", 17", 18", 19" or 21"





- The chairs will be available with or without a commode pan and cradle. Height implications are included on the chart below.
- There is an option for 1" or 2" spacers to raise the seat / clearance heights.

Consideration needs to be given to the needs of anyone else in the property and this decision to refuse chair raise on this basis must not deprive someone else of the only suitable height chair in the property. When there are two sitting rooms, the most appropriate chair in the property should be used. It is appropriate for the Person to use only one sitting room unless they wish to self-fund an alternative.
- Only one chair will be raised per Person.

Practice guidelines

- Chair raisers shift the centre of gravity on a chair and reduce the stability of the chair. Consider placing the chair against a wall.

Carers' considerations

When making recommendations about appropriate sitting, consider the needs of the carer as not to deprive them of appropriate seating e.g. when the only seating in the property is a settee the carer will have to use this also.

Contraindications and safety considerations

If the Person drops down heavily onto seating, the raised chair/ settee will be more likely to tip up.

Weights limit: 318kg per pair or as described by the technician.

- Service User is unable to turn in bed independently. AND
- Multi-disciplinary professionals (to include at least Nursing and OT) have determined the ToTo is required to prevent or treat pressure ulcers.

The maximum rest period being 2 hours.

The pump mechanism has an analogue interface. There is a dial to represent cycle length times and therefore turning times cannot be guaranteed. The tilt will always be 30° as there is not functionality to reduce this.

OT or Nurse can place the order for the "specials panel" account to authorise however the rest of the MDT should be named in the authorisation notes.

There is no clinical reasoning form for ToTo, therefore the prescriber is required to demonstrate in the authorisation notes what the impact would be of non-provision e.g. night time carers, admission to residential care, pressure ulcer development etc.

Carers' considerations

"Whisper guiet" operation at less than 20db.

No carer intervention required.

CPR valve included for rapid deflation when required.

Contraindications and safety considerations

If the ToTo is to be used with the bed is in an elevated position, the Service User needs to have their head supported to prevent lateral rotation at the neck.


